

**Addendum No. 1 to the
Memorandum of Understanding¹
between
Participating UN Organizations²,
and
the UNDP Multi-Partner Trust Fund Office
regarding the Operational Aspects of a
Papua New Guinea UN Country Fund**

WHEREAS, the Participating United Nations Organizations signing this Memorandum of Understanding (hereinafter referred to collectively as the “Participating UN Organizations”) have developed a **Papua New Guinea UN Country Fund** (hereinafter referred to as the “Fund”) starting on **1 June 2009** and ending on **31 December 2022³** (hereinafter “End Date”), as may be amended from time to time, as part of their respective development cooperation with the Government of **Papua New Guinea** (hereinafter referred to as the “Host Government”), as more fully described in the Terms of Reference of the Fund dated **7th April 2009** (hereinafter referred to as the “TOR”), a copy of which is attached hereto as ANNEX A, and have agreed to establish a coordination mechanism (hereinafter referred to as the “Steering Committee”) ⁴ to facilitate the effective and efficient collaboration between the Participating UN Organizations and the Host Government for the implementation of the Fund;

NOW, THEREFORE, on 12 November 2021, the Steering Committee has decided to extend the Country Fund until 30 June 2023.

The Memorandum of Understanding between the Participating UN Organizations and the UNDP’s MPTF Office (acting as Administrative Agent) is therefore modified as follows:

Preamble:


All other terms and conditions of the Memorandum of Understanding remain unchanged.
